The results of the Primary: Joyce thanked everyone who worked on the Write In Biden campaign. Our town-by-town results are on the PAD facebook page. 74% of the Democratic ballots in our area were Biden write-ins.

Carlos Cardona, intro for his run for SD2: Carlos did a great job announcing that he is running for Senate. He has coordinated with NHDP and is assured there will be no primary.

Suzanne Smith: Most of you know by now that our good friend Suzanne Smith died on January 6 after a six year battle with cancer. Suzanne was a very special person and a close friend to many of us. She served six terms in the house and was chair of Resources, Recreation, and Development. She did extensive work on many environmental committees. Yet she somehow found time to show up for visibility and canvassing. She will be greatly missed. We had a moment of silent meditation to remember our friend, Suzanne.

Half of that district — and the most Democratic part — is under Mascoma Forward, and they are working on it. Carolyn's husband, Richard Lobban, is considering running in HD10 (Bristol, Bridgewater).

OUR SPEAKER: Reagan Bissonnette is the Executive Director of the Northeast Resource Recovery Association. NRRA is the oldest and largest cooperative-model recycling nonprofit in the United States. NRRA helps our transfer station to find end markets for our recyclables, so she knows a bit about recycling and waste reduction. She is also on the New Hampshire Solid Waste Working Group, which assists the DES with solid waste planning and policies. Before joining NRRA, Reagan worked in land conservation and practiced law as a corporate attorney.

Ms. Bissonnette discussed the process for about a half-hour and then took questions. Under discussion was the problem of Styrofoam, which is too light and bulky to be profitable in the recycling process.
