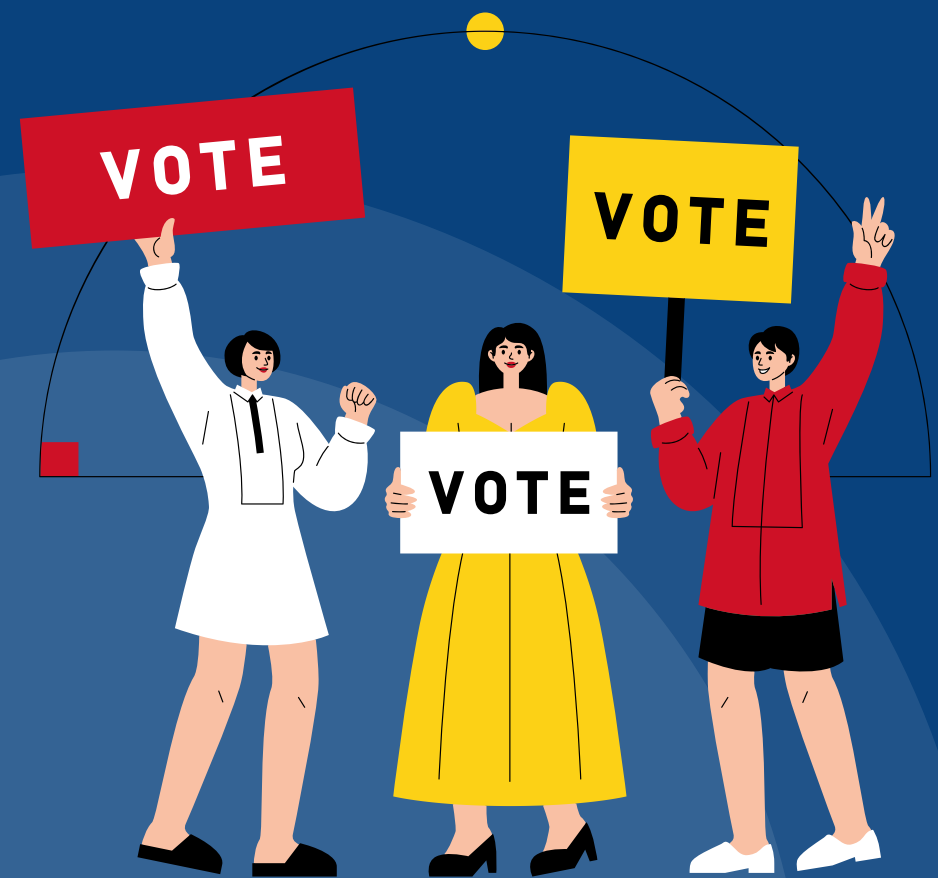

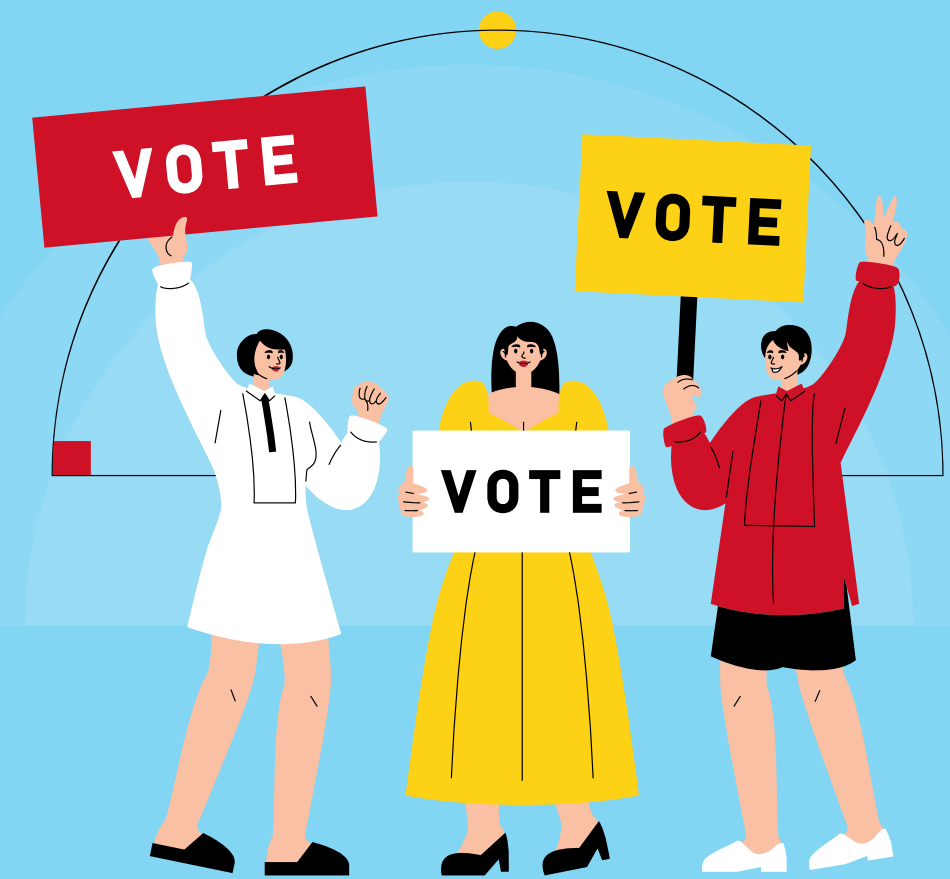


What Does the Voter Protection Team Do?

The Voter Protection Team ensures **EVERY** eligible Granite Stater can register, vote, and have that vote counted.

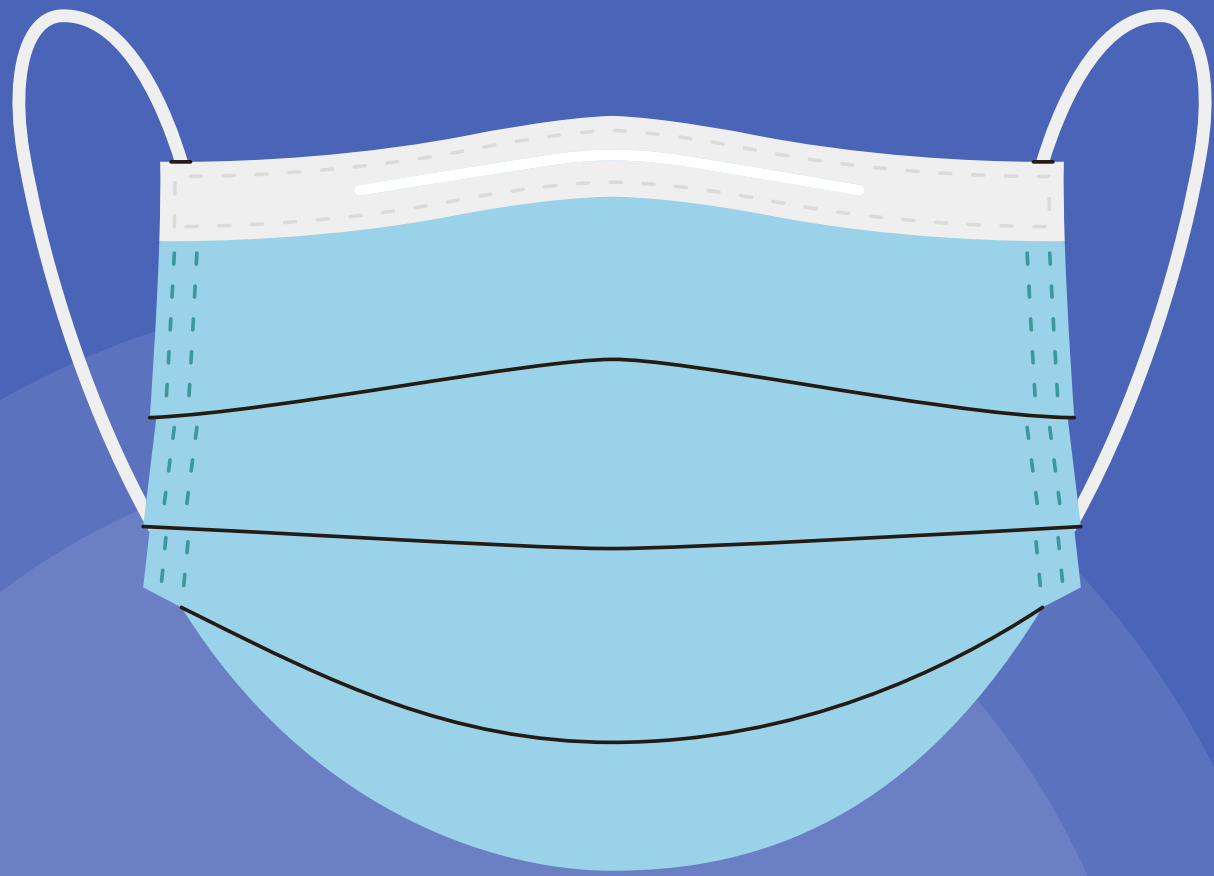
Right now, there are dangerous attempts to undermine confidence in elections.

COVID-19 and Absentee Voting

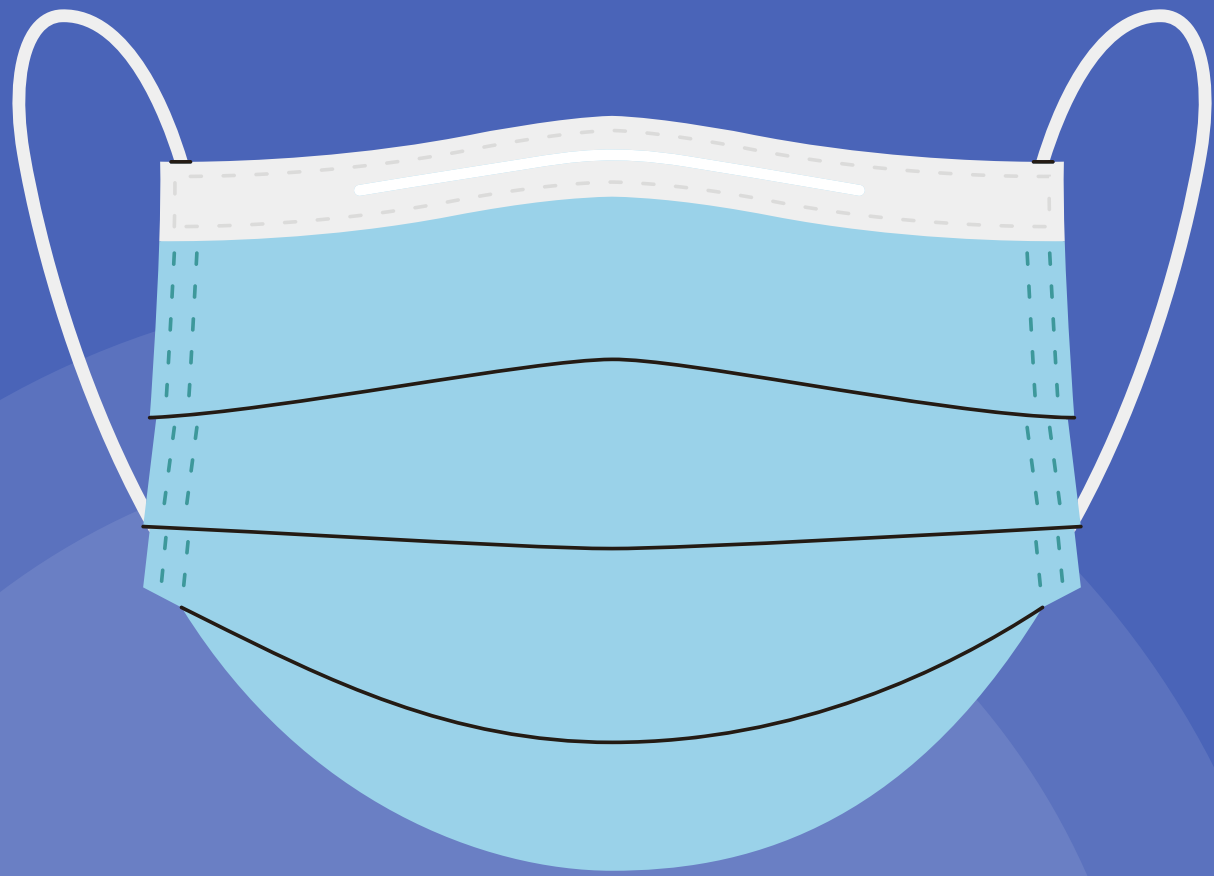


The Secretary of State sent a letter to Clerks in July 2022 regarding COVID-19 and absentee voting.

Key Takeaway:

- Voters can no longer vote absentee solely **for fear of spreading or contracting COVID-19**

COVID-19 and Absentee Voting



Specifically, the Secretary of State explained “disability has the same meaning today as it had pre-pandemic.”

Now, “a person can register and vote absentee if, **based on their own health circumstances, medical authorities advise them to avoid going out in public.**”

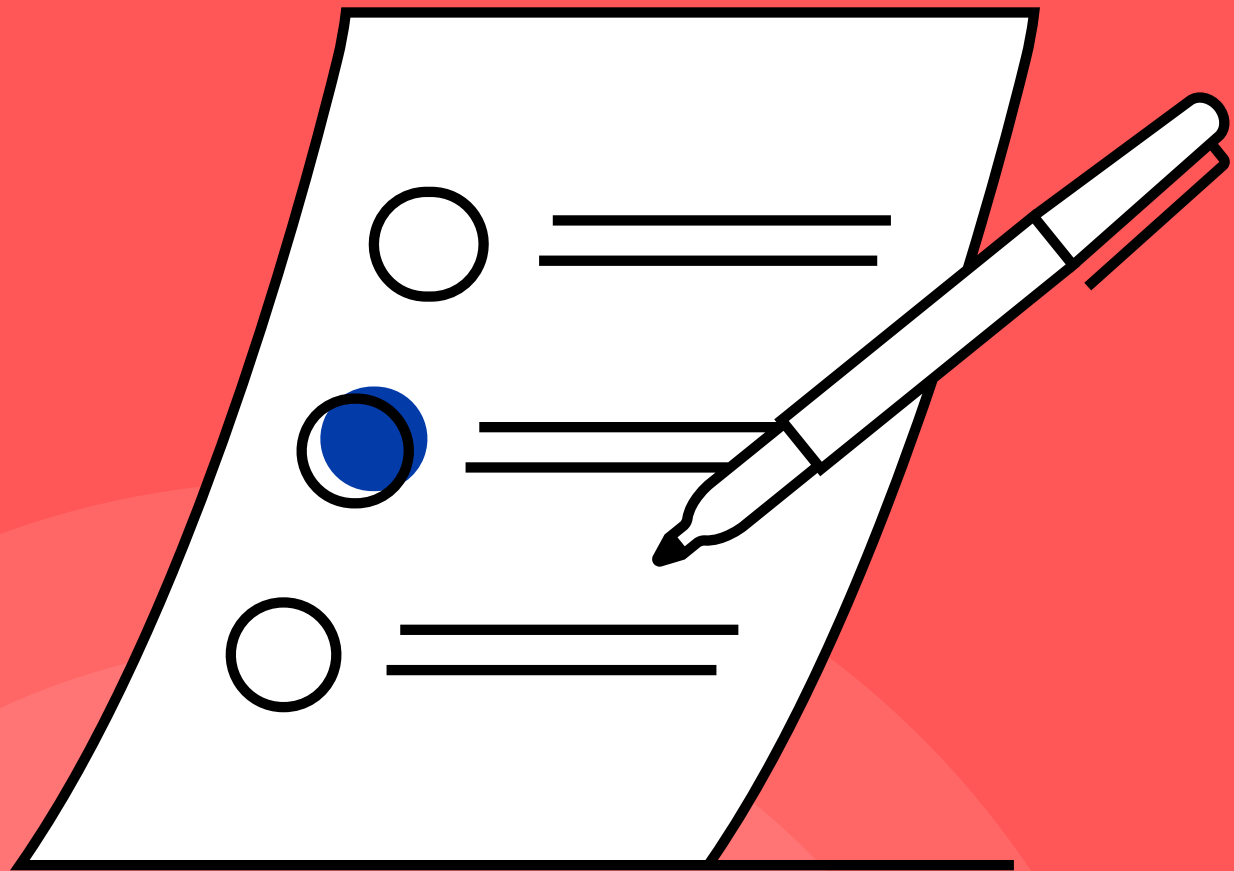
This applies to:

- 1. voters with symptoms of a communicable disease or illness;**
- 2. voters who, due to their own health circumstances, limit public exposure in their day-to-day life as a preventive measure.”**



The Threats to Elections in New Hampshire

SB 418



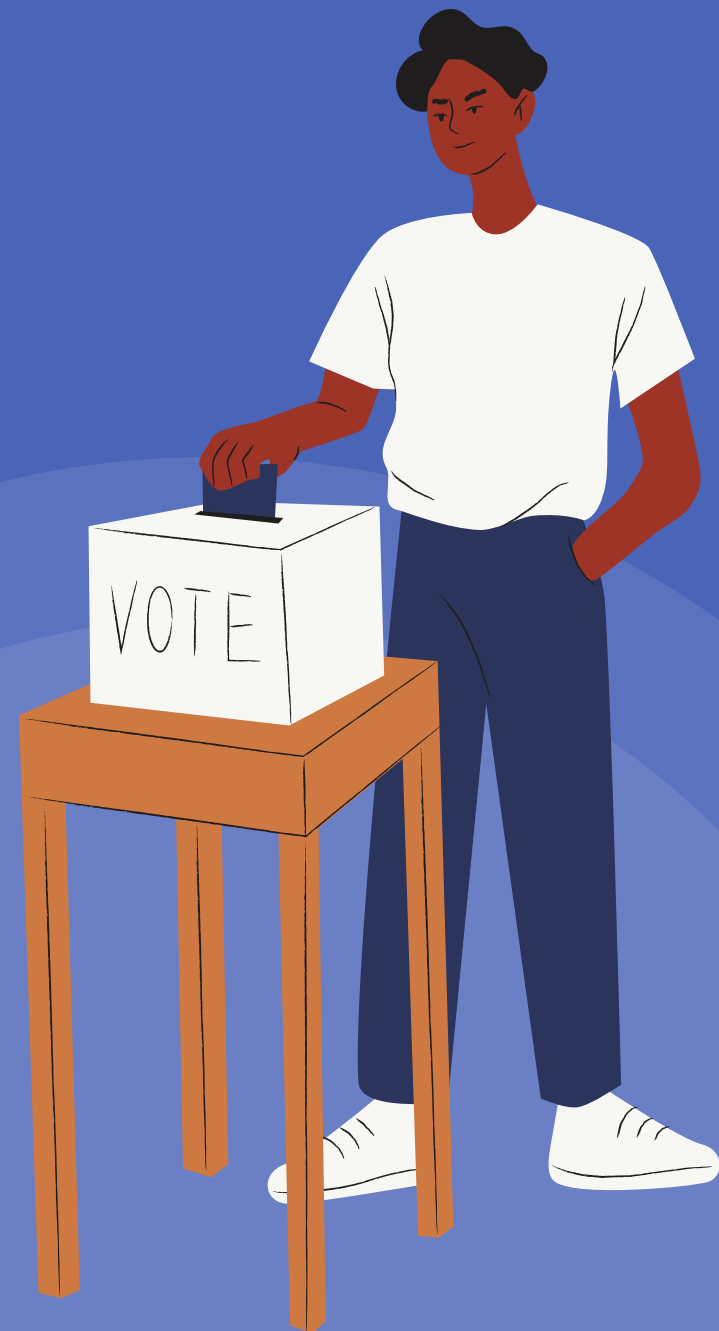
Governor Sununu signed SB 418 into law, a bill that creates affidavit (provisional) ballots for certain NH voters registering on Election Day.

When implemented, it will:

- Violate UOCAVA,
- Result in eligible voters not having their vote counted
- Undermine the secret ballot
- Delay election results and threaten FITN.

Fortunately, this bill will not go into effect until 2023.

Threats to NH Elections



Voter Integrity Group

The Voter Integrity Group is a right-wing group seeking to undermine confidence in New Hampshire's elections and further the Big Lie.

Removal of Voting Machines

Big Lie conspiracy theories have led to an effort to remove voting machines and move to hand counts.

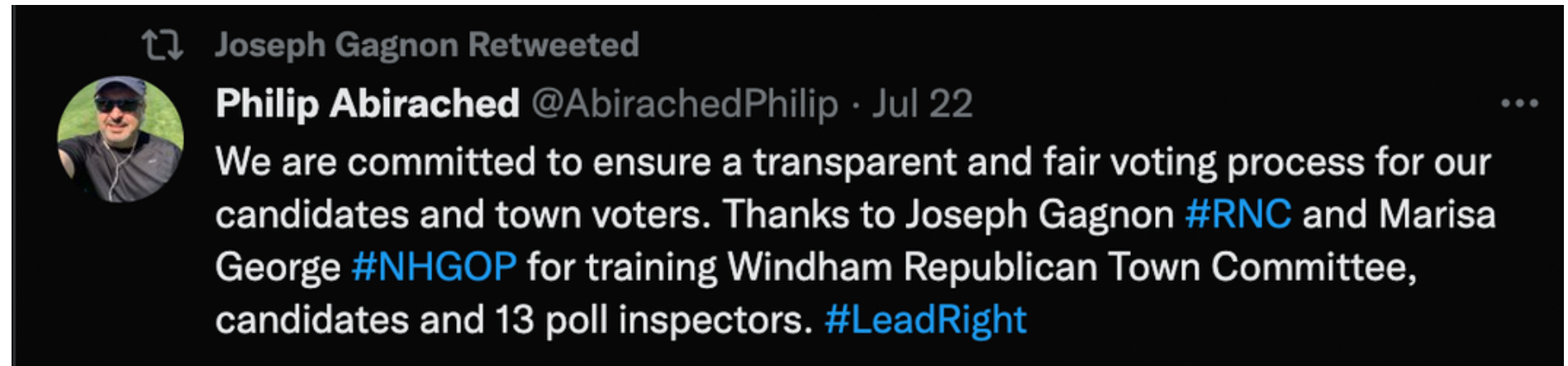
The NHGOP is continuing to push its anti-voter agenda

NH GOP Voter Integrity

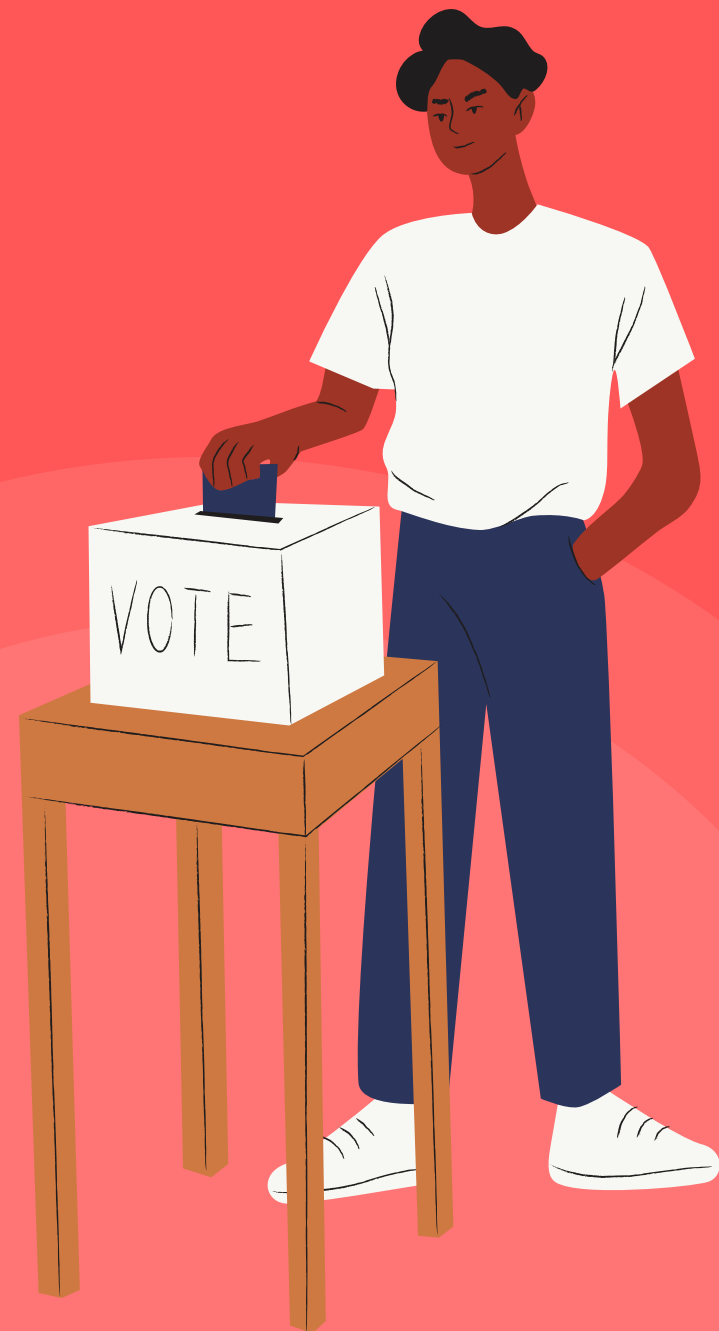


The GOP is actively organizing poll challengers for Election Day.

Removal of Voting Machines



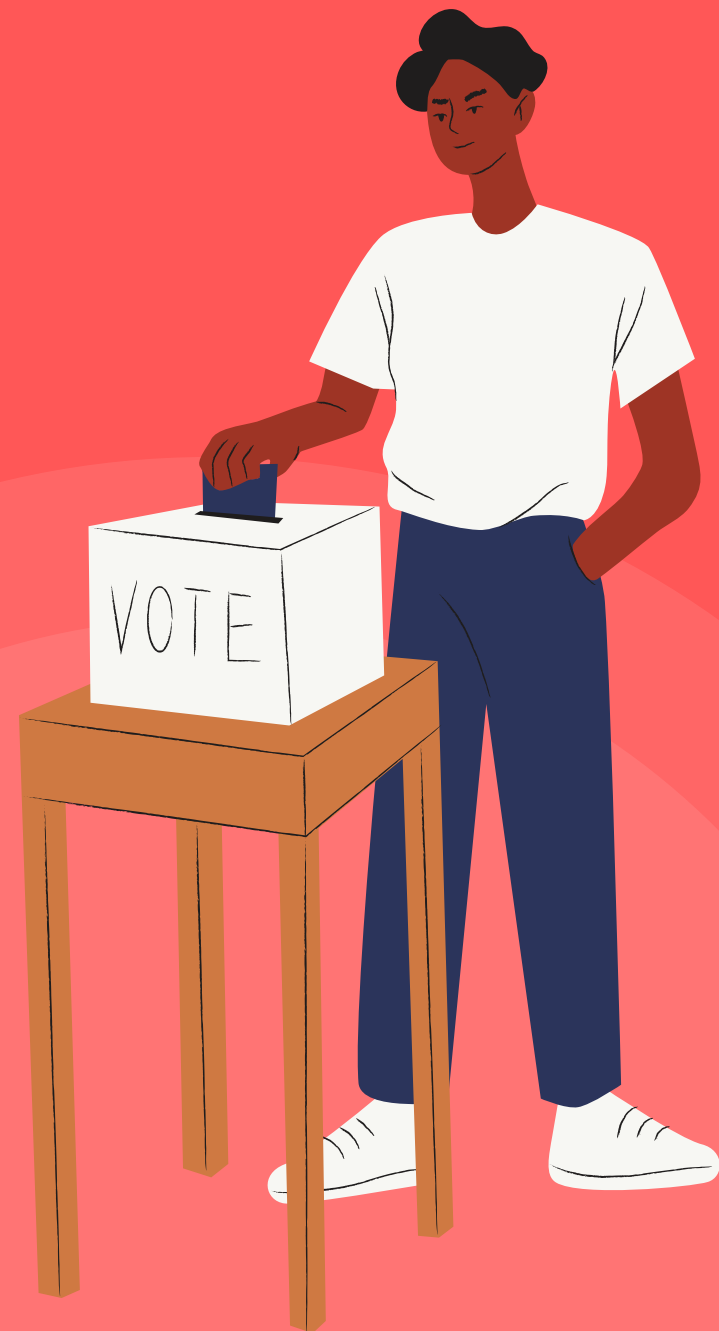
Big Lie proponents spent the Fall and Spring attempted to have towns remove voting machines.

They sought to remove voting machines and move to less reliable hand counts.

Voter Suppression Bills



The NHGOP in Concord has been pushing an anti-voter agenda for years. The Big Lie is exacerbating it.

This past year, they attempted to:

- To criminalize election workers
- To require a third-party (Arizona-style) audit
- To pass an extreme gerrymander

They succeeded in passing:

- SB 418 - "Affidavit" Ballots
- HB 1567 - Investigation of election workers
